69th Annual Meeting

The 69th Annual Meeting will be held at 6:30 p.m. March 9, 2026, at the Historical Galveston Water & Electric Light Community Center, 715 30th St., in Galveston (doors will open at 5:30 p.m.). All members are invited to attend. Nominations cannot be made from the floor, and the election will not be conducted by ballot when there's only one nominee for each position to be filled. Nominations will be posted in a conspicuous place at the credit union office by Feb. 2 (35 days before the annual meeting).

The election will be conducted at the annual meeting. Irrespective of the number of shares, no member has more than one vote. A plurality vote determines all elections. When only one member is nominated for each position to be filled, the board chairman may take a voice vote or declare each nominee elected by general consent or acclamation at the annual meeting. No member may vote by proxy. An organization, incorporated or otherwise, holding membership in the credit union may only be represented by one person authorized to represent it, and said authorization shall be maintained on file in the credit union.

Nominations can also be made by petition. Nominees must be made with 1 percent of members' signatures (minimum of 138). Nominations by petition must be sent to the Credit Union Board of Director Secretary via registered mail by Jan. 26. Candidates must submit a statement of qualifications and biographical data with the petition.
